

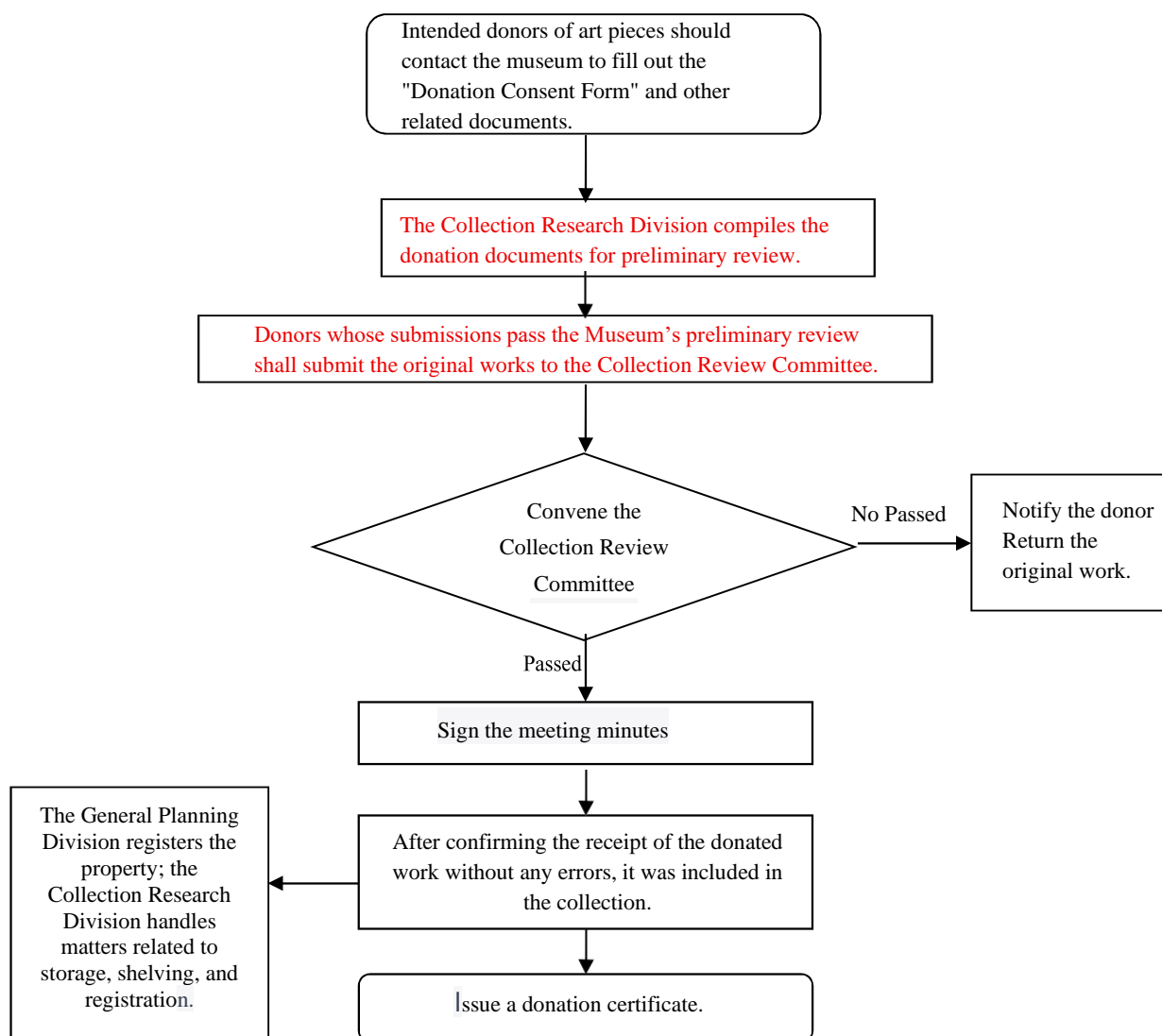
Chiayi Art Museum Collection Regulations

Approved on December 28, 2021

Revised at the Museum Affairs Meeting on May 5, 2025

1. Chiayi Art Museum (hereinafter referred to as “the Museum”) establishes these regulations based on the need to preserve cultural and artistic assets in order to meet the requirements of collection, preservation, exhibition, research, and education of relevant items. The Museum conducts collection activities and assumes responsibility for their proper preservation and management.
2. **Scope and Criteria of Donation:**
 - (1) Artworks from various periods that reflect the development of Chiayi’s art history, with priority given to those that demonstrate the trajectory of such development.
 - (2) Artworks with artistic, cultural, or historical value related to Taiwan and local traditions.
 - (3) Promising contemporary artworks associated with Chiayi.
 - (4) Artworks that align with the Museum’s collection policy or are deemed to have collection value by the Museum’s Collection Review Committee.
3. Individuals who intend to donate artworks may notify the Museum to initiate an evaluation process, which shall be conducted in accordance with the Museum’s standard operating procedures for the acceptance of donated artworks.
4. **Donation Procedure:**
 - (1) Donors are required to complete and sign a Donation Agreement Form.
 - (2) Donated artworks shall be reviewed and approved by the Museum’s Collection Review Committee, composed of appointed experts and scholars. Only those approved may be formally included in the collection. Upon approval, the Museum will carry out the necessary procedures for property registration and accession in accordance with relevant regulations.
5. The price of collected artworks is determined by the Collection Review Committee.
6. Artworks approved for inclusion in the collection will be reported to the Chiayi City Government, and upon approval, a certificate of collection will be issued by the Museum.

7. Donor Agreements and Declarations:

(1) The donor agrees to donate the artwork to the Chiayi City Municipal Museum without any conditions.

(2) The donor guarantees that the donated artwork does not infringe upon the rights or copyrights of any third party, including but not limited to issues regarding provenance and ownership. Should any legal disputes arise, the donor shall be held fully responsible.

(3) The donor agrees to grant the Museum full professional autonomy in the planning and use of the donated work, including but not limited to exhibition, restoration, education, relocation, placement, loan, promotion, marketing, and merchandise development.

- (4) Once the donation is reviewed and approved for inclusion in the Museum's collection, the donation shall be final and irrevocable. The donor and any legal heirs shall not withdraw, revoke, or request the return of the donation. If the donation is not approved, the review materials will be retained for archival purposes, and the original artwork will be returned to the donor.
